SHAKE WELL BEFORE USING

Unless otherwise noted, hold container upright and spray from a distance of 12 to 15 inches.

When treating surfaces and fabrics where water alone could stain, spray in an inconspicuous area to test for possible staining or discoloration.

# INDOORS:

Cockroaches, Silverfish, Crickets, Scorpions and Spiders: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible. Ants: Spray trails, nests and points of entry. Spray on ants where possible.

TO KILL **Bed Bugs**: Apply as a spot treatment to cracks and crevices, around baseboards, floorboards, bed boards and walls. First, thoroughly clean and air mattresses and springs. Then spot treat only areas that may harbor bed bugs, concentrating on utils, folds and series. Allow treated articles to throughly dry before use. Repeat fatter 4 weeks if necessary. To treat beds: Disassemble the bed frame and remove bedding. Do not apply to bedding, Wash bedding and dry using high heat to kill bed bugs. Apply this product to the bed frame, mattress and box spring. Application to mattresses and box springs is for treatment of seams, edges and tuffs only. Do not saturate the mattress or box spring. On **Upholstered Furniture and Drapes:** test fabric in an inconspicuous area to insure dyes will not blede. Apply as a spot, crack & crevice treatment to fabric surfaces paying particular attention to tufts and seams. Spray until damp. Do not use on officiate fabrics. Allow furniture to dry thoroughly before using. On **Earpes:** DO NOT APPLY AS A BNOADCAST SPAN AT RESIDENTIAL SITEs, in these sites apply only as a spot, crack & crevice treatment. Use an overlapping pattern to insure total coverage. After application, brush the surface of the carpet with a broom or brush to insure deep penetation. Allow carpet to dry thoroughly before retenting the treated area. Drying time can be accelerated by using a fan. Leave room while fan is in use until carpet is dry. On **Mattresses** - spray the sides of mattresses until damp, paying particular attention to tufts and seams. Allow to dry thoroughly before eusing.
